Glossary of Terms

Net Rate: This is the contractual rate of interest paid from which tax is deemed to have been deducted at the appropriate rate, currently 20%.

Gross Rate: The contractual rate of interest payable not taking into account the deduction of tax.

AER stands for Annual Equivalent Rate and illustrates what the interest rate would be if paid and compounded each year.

Tax Free: This is the rate payable where interest is exempt from tax.
